- This approval relates to the manufacture of door frames for use with specified CERTIFIRE
  approved fire doors. Subject to the undermentioned conditions, the doors when fitted in the
  frame and with hardware and seals specified in this certificate are designed to meet the
  requirements as detailed in the relevant certificates.
- This certification is provided to the client for their own purposes and we cannot opine on whether it will be accepted by Building Control authorities or any other third parties for any purpose.
- 3. All frames shall be manufactured in accordance with the frame specification as defined in Figure 1. The frames shall be of the following specification:
  - Type 1 Twice primed, moisture resistant MDF
  - Type 2 Wood veneered, moisture resistant MDF
- 4. The frames are approved for use with

CERTIFIRE approved FD30 single-acting, single leaf, latched doorsets of maximum leaf dimensions 2040 mm high by 926 mm wide and of minimum thickness 44 mm. The doorset assemblies shall consist of timber faced and edged leaves with timber, cellulosic or mineral cores in timber frames (Code ITT).

Only doors as indicated in Table 1 are approved for installation in W. Howard FD30 MDF frames.

For any other door types/configurations, please refer to the door manufacturers CERTIFIRE Data Sheet and detailed installation instructions.

- 5. Processing is conducted in accordance with W. Howard procedures.
- 6. The process is approved on the basis of on-going certification of quality management system to ISO 9001.



Figure 1 - Details for MDF Door Frames







Figure 2 - Details for MDF Door Frames





  not be removed or replaced with any other seals. Where smoke seals are specified then
  additional CERTIFIRE approved seals will be supplied.
- The hinges supplied with the frames are CE marked for use on timber fire doors and should not be changed for alternative items.
- It is recommended frames and doors are installed by fully trained FIRAS accredited installers.
